

This facility operates a ready-mix concrete batch plant with two split silos, batching equipment , mixing trucks, aggregate and sand storage bins, conveying equipment and an office

The west silo is split, the northern most side contains flyash and has the southern most side contains cement. The east silo is also split, the northern side contains cement and the southern most side contains slag. Each of the compartments has an identical C&W Model LPR-65 silo-top mounted baghouse (four total), the serial number for each is unknown.

Emissions truck batching operations are controlled by a ground-mounted C&W Model RA-120 central dust collector. The weigh scale for the truck loadout is controlled by a C&W Model CP-35 dust collector, the serial number for unit is also unknown.

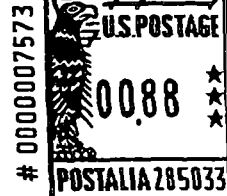
