This is to acknowledge that your notification of intent to use the authority of Rule 62-210.310 to operate your facility was received on March 28, 2008. We have assigned ARMS No. <u>1270184-002</u> to this facility.

As you know, pursuant to Florida Statutes section 403.814, authority to operate under general permits commences thirty days after receipt of the registration form unless you have been notified by this office that your facility has not shown entitlement to operate pursuant to the rule provisions.

For your information, authority to operate pursuant to Rule 62-210.310 expires after 5 years. Therefore, a new registration form must be received no later than 5 years after the date your notice was received as indicated above. If your general permit rule conditions require testing, such testing must be completed within the time frame specified in the rule.

Description of Facility Below, or as an attachment to this form, provide a description of the concrete batching plant operations at the facility in sufficient detail to demonstrate the facility's eligibility for use of this air general permit and to provide a basis for tracking any future equipment or process changes at the facility. Describe all air pollutant-emitting processes and equipment at the facility, and identify any air pollution control measures or equipment used. The batch plant consists of a single 1200 barrel silo with a baffle that divides the silo into 2 compartment on a 60-40 split and a single silo. Each compartment of the split silo, as well, as the single silo are equipped with a WAM silotop baghouse (3 total). The drop point has a central dust collector consisting of a ConECo PJ1400 Central Dust Collector. The cement Batcher Vent is a ConECo BV14 All equipment is connected to the batch panel which allows operations to engage egiopment when a tanker is off loading and when a redi-mix truck is being loaded. The load rate for conventional material is approximately 25 tons per hour.
