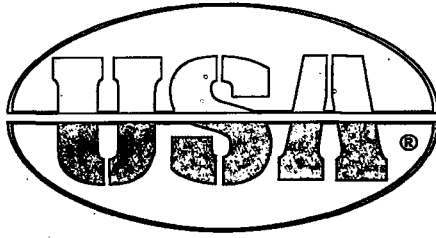

Description of Facility

This plant is a Mertz batching plant with 10 yard batching hopper. Maximum load capacity 180 cubic yards per hour. There are two overhead cement silos; capacities of 100 and 150 tons as well as a fly ash silo with a 56 ton capacity.

This facility combines rock, sand, water and cement to make ready mixed concrete. The mixture is loaded into a ready mix truck and transported to job sites. The plant operates 5.5 days a week. The plant is in operation based on market demand.

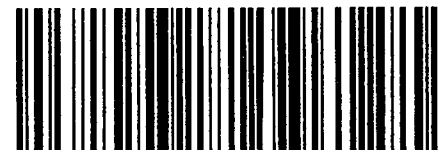

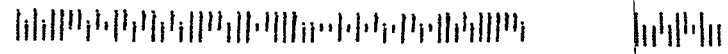
