

- EU 002 Southwest Silo - Flyash controlled by a WAM VFSC 29043 baghouse
- EU 003 Northeast Silo - Cement Controlled by a WAM VFSC 2943 baghouse
- EU 004 Central Dust Collector controlling the Load out
