I need some help with your Concrete Batching registration forms in that some of your equipment description information and processes are not quite as detailed or specific as they could be.

I called yesterday and left a message on your phone regarding the first item #7775286 immediately below. The second item, #7775286 is also missing more specific detail.

1) AIRS ID# 7775286-002-AG, COUCH READY MIX USA dba VILLA TASSO MINI, 10640 HWY 20 W, NICEVILLE, FL 32578 - Our database reflects that no equipment is present at this location. Your submitted form says there is a Cemco portable CCB Plant w/ two silos, 50 & 52 T cap, no other identifying info provided, such as Model #'s, emission control devices, silo capacities (Mfr, model #'s filter area) etc. Is there a truck loadout, and how are fugitive emissions controlled at the drop point? Can you confirm, and also supply more specific identification information as called for on the forms.

2) AIRS ID# 7775286-007-AG, COUCH READY MIX USA dba VILLA TASSO PLANT, 10642 HWY 20 W, NICEVILLE, FL 32578 - Submitted form (Page ten (10)) does not tell me how many silos are located on site. What are the MERTZ baghouse model numbers? Is there a truck loadout, and how are fugitive emissions controlled at the loadout drop point or is the concrete wet loaded into the trucks? For future reference, try to keep all Fugitive emissions Reasonable Precautions information on Page nine (9) and all Confined emissions unit equipment & Emissions Control equipment information on Page ten (10).
