
This is to acknowledge that your notification of intent to use the authority of Rule 62-210.310 to operate your facility was received on December 26, 2007. We have assigned ARMS Number 7775465-001 to this facility.

As you know, pursuant to Florida Statutes section 403.814, authority to operate under general permits commences thirty days after receipt of the registration form unless you have been notified by this office that your facility has not shown entitlement to operate pursuant to the rule provisions.

For your information, authority to operate pursuant to Rule 62-210.310 expires after 5 years. Therefore, a new registration form must be received no later than 5 years after the date your notice was received as indicated above. If your general permit rule conditions require testing, such testing must be completed within the time frame specified in the rule.



This application is for a 2006 Rubblemaster Compact-Recycler Model RM60, Serial No. RM60-0298. The crusher has two spray bars with six individual spray nozzles with a design capacity of 55 to 65 tons per hour. The dust suppression system includes a 132 gallon water tank. The crusher is powered by a water cooled Deutz diesel engine BF4M1012E.

The crusher is portable and a Relocation Notification will be filed prior to moving the crusher with the appropriate regulatory agencies.
