This is to acknowledge that your notification of intent to use the authority of Rule 62-210.310 to operate your facility which was received on December 27, 2007. We have assigned ARMS No. 7775470-001 to this facility.

As you know, pursuant to Florida Statutes section 403.814, authority to operate under general permits commences thirty days after receipt of the registration form unless you have been notified by this office that your facility has not shown entitlement to operate pursuant to the rule provisions.

For your information, authority to operate pursuant to Rule 62-210.310 expires after 5 years. Therefore, a new registration form must be received no later than 5 years after the date your notice was received as indicated above. If your general permit rule conditions require testing, such testing must be completed within the time frame specified in the rule.

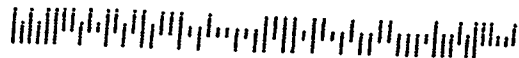

This is an application to operate a relocatable non metallic mineral crusher manufactured by BL Pegson on *JUNE 06*. It is a Model *428 TRAPACTOR*, SN *280208 01*. The crusher is powered by a CAT *C9.300* HP engine at *1800* RPM. The belt is 32' long, 3'3" wide with a discharge height of 12'10". The design capacity is 200 TPH. There are three spray bars on the crusher, one is located at the in-feed to the crusher, the second bar is located at the out-put and the third bar is located at the end of the product discharge conveyor. Each bar is 48" long.

This unit is owned by Powerscreen of Florida, Inc. and is intended to be used as lease/rental equipment. Powerscreen of Florida, Inc. will not be operating or overseeing the operation of this machine.
