This is to acknowledge that your notification of intent to use the authority of Rule 62-210.310 to operate your facility was received on March 10, 2008. We have assigned ARMS No. <u>7775505-001</u> to this facility.

Therefore, a new registration form must be received no later than 5 years after the date your notice was received as indicated above. If your general permit rule conditions require testing, such testing must be completed within the time frame specified in the rule.
