

It is equipped with a 60" x 23' conveyor and a 610 hp Mercedes Benz OM 502 LA Diesel Engine. This unit is capable of producing 15-60 tph depending on machine settings. The mill is a 1050rpm upswing flail hammermill with a precrusher in the top housing.
