

This application is for the facility startup of a Doppstadt SM726 Trommel Screen SN W9072122492D38040. This machine has a 101hp Mercedes Benz OM 904 LA Diesel Engine. It has a replaceable drum for quick change of product size. The screening drum is continuously cleaned by hydraulically tensioned brushes w/scraper. It is capable of producing 60 tph depending on how machine is set. It has two separate conveyors.
