This application is for a facility startup of a Doppstadt DW3060SA Slow Speed Shredder. The serial number is W930732492D38051. It is equipped with two axles that have has (2) 385/65 R22.5 tires/axle. It is equipped with a 10' by 24" shaft and has a 4' by 16' rear conveyor. It is capable of processing 20-80 tph and is powered by a 430 hp Mercedes Benz OM 460 LA diesel engine.
