

This is an application to operate a relocatable non metallic mineral crusher manufactured by BL Pegson on MARCH 2005. It is a Model 429 TRAKPACOR SN 280136GE. The crusher is powered by a CAT (9,300) HP engine at 1800 RPM. The belt is 32' long, 3'3" wide with a discharge height of 11' 0". The design capacity is 200 TPH. There are three spray bars on the crusher, one is located at the in-feed to the crusher, the second bar is located at the out-put and the third bar is located at the end of the product discharge conveyor. Each bar is 48" long.

This unit is owned by Powerscreen of Florida, Inc. and is intended to be used as lease/rental equipment. Powerscreen of Florida, Inc. will not be operating or overseeing the operation of this machine.

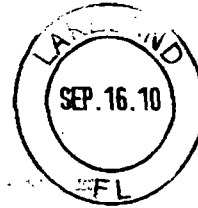
