This is in response to your voicemail message regarding the additional information I was requesting from Clark Learning in order to fill in the equipment identification gaps on the Nonmetallic Mineral Processing Plant AGP Registration Form for the MGL Engineering portable wash plant and associated material handling equipment.

WASH PLANT

I need to clarify whether or not the 125 T/hr feed rate that he indicated on the form is a production rate, or is it the machine rated capacity of the portable wash plant. I am really looking for the **maximum machine rated capacity** regardless of material processed.

Power source – if a RICE, I need make, date of manufacture, model #, S/N, Hp, & fuel type.

CONVEYORS - Need more specific identifying criteria of transfer and stacker conveyors

- Is the feeder hopper (12 cu. yd.) & incline conveyor part of the wash plant, or are these individual, stand alone pieces of equipment? If they are individual, stand alone pieces of equipment then we need similar identification criteria (make, model #, capacity and if separate RICE power unit, make, date of manufacture, model #, S/N, Hp, & fuel type).
