This is an application to operate a relocatable non metallic mineral crusher manufactured by *POWERSCREEN* on *SEPT. 2010*. It is a Model *PC200 XH320*, SN *SEE BELOW*. The crusher is powered by a *CAT C9, 325* HP engine at *2000 RPM*. The belt is *35'* long, *48"* wide with a discharge height of *11'4"*. The design capacity is 200 TPH. There are three spray bars on the crusher, one is located at the in-feed to the crusher, the second bar is located at the out-put and the third bar is located at the end of the product discharge conveyor. Each bar is 48" long.

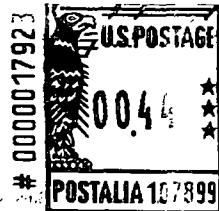
