

This registration is for a 1995 Boehringer Non Metallic Mineral Processor, Model CHAMP-100, Serial Number 12/5912 with a rated capacity of 350 tons per hour. The crusher is powered by a 400 HP Catepillar Engine Model 3406, Serial Number 61B14835 that uses off road diesel at the rate of 12 GPH. The crusher will be used to crush limerock. Assciated with the crusher are various material conveyors for the fines, discharge and stacking of the end product. The conveyors are part of the main crushing operation and do not have make, model or serial numbers.
