"Owner" or **"Operator"** - Any person or entity who or which owns, leases, operates, controls or supervises an emissions unit or facility.

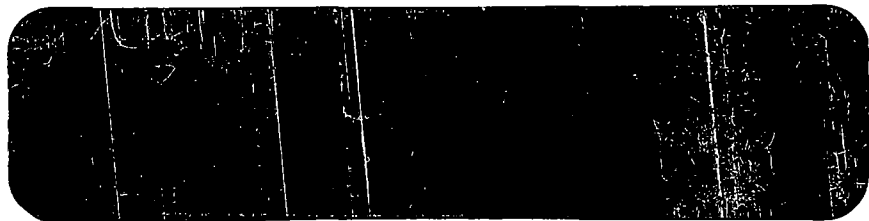
