CFM has enclosed the Concrete Batching Plant Air General Permit Registration Form [new DEP Form No. 62-210.920(2)(b), effective January 10, 2007] for the re-registration of the existing facility.

Also enclosed is the required \$100 air general permit registration processing fee per Rule 62-4.050(4)(p)(2), F.A.C.

In accordance with Rule 62-296.414(4)(a), F.A.C., visible emissions (VE) testing for controlled exhaust points is required to be completed 30 days after commencing operation, and annually thereafter. CFM West Broward is temporarily shutdown and will complete visible emissions testing for the facility within 30 days after the operation commences. In addition, CFM will submit a VE testing notification to Broward County, at least 15 days prior to the established testing date(s).


