Air General Permit Example Registration Worksheet

The Department of Environmental Protection ("Department" or "DEP") has established an "air general permit" at Florida Administrative Code ("F.A.C.") Rule 62-210.310(5)(c) for human crematories. An air general permit is an authorization by rule to construct or operate a specific type of air pollutant emitting facility. Use of such authorization by any individual facility does not require action by the Department. The terms and conditions of the air general permit are set forth in the rule, rather than in a separately issued air construction or air operation permit.

If you are the owner or operator of an eligible facility comprising one or more human crematories, you may register to use the air general permit at Rule 62-210.310(5)(c), F.A.C., by following the general procedures given at subsections 62-210.310(2) and 62-210.310(5), F.A.C. To register, use the Department's electronic registration system (currently under development) or submit all the information specified in the above rules to either of the following addresses, along with the air general permit registration processing fee (\$100.00).

If you properly register to use an air general permit, and are not denied use of the air general permit by the Department, you are authorized to construct and operate the facility in accordance with the general terms and conditions of Rule 62-210.310, F.A.C., and the specific terms and conditions of Rule 62-210.310(5)(c), F.A.C. Your facility may vary, so be sure your registration describes the operations at your facility in sufficient detail to demonstrate the facility's eligibility for use of the air general permit and to provide a basis for tracking any future equipment or process changes. Your registration should describe all air pollutant-emitting processes and equipment at the facility, and it should identify any air pollution control measures or equipment used.

The rules do not require any specific format for the registration. This worksheet, however, has been designed to assist owners and operators. Using it as a template for a general permit registration will help ensure that all necessary information is submitted.

"Biomedical Waste" - Any solid or liquid waste which may present a threat of infection to humans, including nonliquid-tissue, body parts, blood, blood products, and body fluids from humans and other primates; laboratory and veterinary wastes which contain human disease-causing agents; and discarded sharps. The following are also included:

1. Used absorbent materials saturated with blood, blood products, body fluids, or excretions or secretions contaminated with visible blood; and absorbent materials saturated with blood or blood products that have dried.
2. Non-absorbent, disposable devices that have been contaminated with blood, body fluids, or secretions or excretions visibly contaminated with blood, but have not been treated by a method listed in Section 381.0098, F.S., or a method approved pursuant to Rule 64E-16, F.A.C.

"Department" or "DEP" - The State of Florida Department of Environmental Protection.

"Emissions Unit" - Any part or activity of a facility that emits or has the potential to emit any air pollutant.

"Facility" - All of the emissions units which are located on one or more contiguous or adjacent properties, and which are under the control of the same person (or persons under common control).

"Human Crematory" - Any combustion apparatus used solely for the cremation of either human or fetal remains

"Owner" or "Operator" - Any person or entity who or which owns, leases, operates, controls or supervises an emissions unit or facility.


Dear Mr, Richard Dibble::


This is to acknowledge that your notification of intent to use the authority of Rule 62-210.310 to operate your facility was received on March 27, 2008. We have assigned ARMS No. 0150097-001 to this facility.

As you know, pursuant to Florida Statutes section 403.814, authority to operate under general permits commences thirty days after receipt of the registration form unless you have been notified by this office that your facility has not shown entitlement to operate pursuant to the rule provisions.

For your information, authority to operate pursuant to Rule 62-210.310 expires after 5 years. Therefore, a new registration form must be received no later than 5 years after the date your notice was received as indicated above. If your general permit rule conditions require testing, such testing must be completed within the time frame specified in the rule.

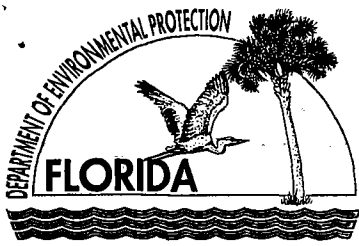

Dear Mr. Henley:

The purpose of this letter is to inform you about a possible violation and request your cooperation in resolving this matter. On January 25, 2012, a Department inspector visited your above referenced facility to witness the annual compliance test. As a result of the Department's visit and a review of the facility's file, the Department believes you may be operating your facility with an Air General Permit registered with our office under Service Corporation International and Southeastern Pet Cremation. Our records do not indicate that Kays, Ponger, and Uselton applied for new permits when you took over this facility. The Air General Permits are non-transferable and each new owner must re-register for a new permit.

Rule 62-210.310(2)(b)4, Florida Administrative Code states: the facility identification number (if known) and the reason for re-registration (one or more of the following: impending expiration of the term for air general permit use; change of ownership of all or part of the facility; proposed new construction, modification, or other equipment change that requires registration pursuant to paragraph 62-210.310(2)(e), F.A.C.; or any other change not considered an administrative correction under paragraph 62-210.310(2)(d), F.A.C.). Since you are the new owners, operating this facility without the properly registered permit is a violation of Florida law.

The Department seeks your assistance in resolving this issue. We are attaching two registration applications for you to complete and submit to the Department. The first application is an application for the human crematory. On this application, please list your human crematories, emission units 1 and 2. The second application is for the animal crematory. Please list your animal crematory emission unit 3 on this application. The fee will be \$200, \$100 per application. The Department requests these applications be submitted to our Tallahassee Office within thirty days after receiving this letter.

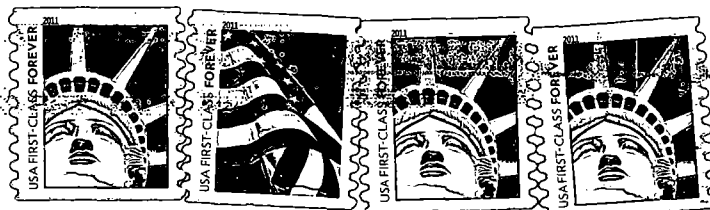
