
Inactivation of Air General Permit Registrations

Good morning Ray!

Please forgive me if we have discussed this issue before, but this is just a gentle reminder, that if any Air General Permitted facility has been previously entitled (i.e. the most current entitlement) through the Tallahassee office and it requires INACTIVATION, please forward or direct those requests to our office. We cannot maintain accurate recordkeeping (hardcopy & electronically scanned files) when INACTIVATED by another entity occurs.

If a facility was last entitled by DERM, or another FDEP District or Local Program Office, then by all means, go ahead and process the INACTIVATION. Tallahassee does not maintain hardcopy or electronically scanned files for those facilities that were not permitted here in Tallahassee, prior to assuming the AG permitting function. If they were last entitled by DERM or another FDEP District or Local Program Office, they are part of the respective office's recordkeeping function.

I bring this to your attention since we currently have a new entity that has recently submitted a PERC Dry Cleaner AGP Notification Form for a Dry Cleaning facility in your area. ARMS (0250771) indicates that it was changed to INACTIVE in August 2009, but our hardcopy & electronic files show that it remains as an ACTIVE facility. It was never closed out in our files.



Thank you for helping us in our efforts to maintain an accurate recordkeeping and database system as we possibly can.

Also, Marnie Brynes has been trained and is currently handling all of the Perchloroethylene Dry Cleaners Air General Permit Registrations and any associated administrative issues and inquiries concerning dry cleaners.
