The Department has received the Title V General Permit Notification Form for the dry cleaning facility that you submitted on May 25, 2007.





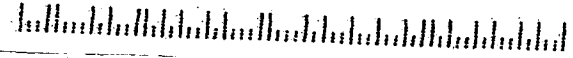
