

As you know, pursuant to Florida Statutes section 403.814, authority to operate under general permits commences thirty (30) days after receipt of the registration form unless you have been notified by this office that your facility has not shown entitlement to operate pursuant to the rule provisions.

For your information, authority to operate pursuant to Rule 62-210.310 expires after five (5) years. Therefore, a new registration form must be received no later than five (5) years after the date your notice was received as indicated above. If your general permit rule conditions require testing, such testing must be completed within the time frame specified in the rule.

Description of Facility

Our CSIPs (Composite Structural Insulated Panels) come in 3 standard thicknesses - 104mm, 64mm, and 44mm, depending on whether they will be used for internal or external walls and/or roofs. Our panels can be made out of polyurethane (PU) for building construction, or can be made with honeycomb for floating platform applications.

Our panels can also be made to spec in virtually any dimension, shape, and/or level of thickness that is required. For example - in the case of hurricane shutters, our panels will be shaped in the dimension, shape, and thickness of a plywood board, or a metal sheet shutter. In this particular example our panels will be stronger than the current materials used in the industry, but in addition they can be custom made to have the exact specs of an arch window or an oddly shaped door. It can be made with matching colors of existing walls.

InnoVidaPanels™, InnoVidaResin™ and InnoVidaBond™ are produced using proprietary synthetic composite materials and industrial processes similar to those now generally accepted by the marine and aircraft construction industries. InnoVidaPanels™, made from InnoVidaResin™, provide a stronger, lighter, and more flexible alternative to traditional construction materials of cement, steel or bricks. For example, panels can take a vertical load of 50 tons/m² and horizontal load of 2 tons/m². Because of their unique properties, InnoVidaPanels™ are nonflammable, waterproof, and hurricane resistant up to 186mph (300km/h), and their polyurethane insulation allows for significant noise reduction and better preservation of room temperature. Additionally, the use of InnoVidaBond™ materials to join the panels together results in a chemical fusion rendering the structure virtually waterproof. Construction of structures made from InnoVida materials can be completed in a few days without requiring heavy equipment.

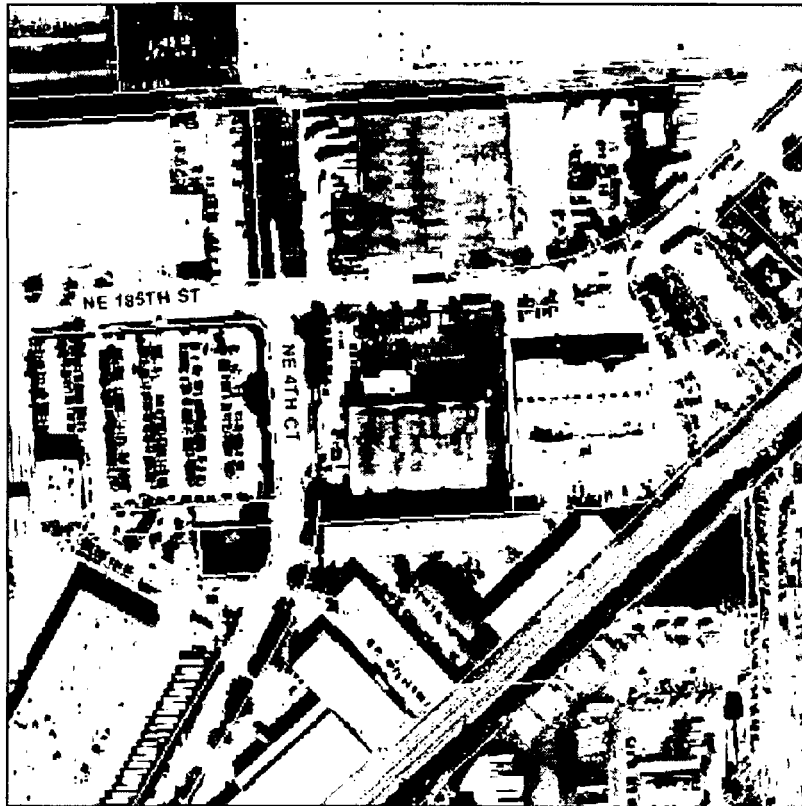
The facility uses proprietary tables, equipment and resins to manufacture the composite panels. They are currently purchasing polyisocyanurate panels for use in the process.
