CEMEX Construction Materials Florida, LLC. takes reasonable precautions to control unconfined emissions from hoppers, storage and conveying equipment, conveyor drop points, truck loading and unloading, roads, parking areas, stock piles and yards as required by Rule 62-296.320(4)(c), F.A.C. The following are the precautions taken at this facility.

Regular sweeping and/or the application of water to the yard is used to control airborne emissions.

Regular removal of particulate matter from roads, paved areas and work areas serves to reduce airborne particulate matter.

The height of stock piles are reduced to mitigate wind entrainment of particulate matter from the aggregates.

Description of Facility

Below, or as an attachment to this form, provide a description of the concrete batching plant operations at the facility in sufficient detail to demonstrate the facility's eligibility for use of this air general permit and to provide a basis for tracking any future equipment or process changes at the facility. This facility consists of a ready mix concrete plant. This plant uses cement, flyash and aggregate materials to produce ready mix concrete. Dust emissions are controlled by the following methods.

Emissions generated during the pneumatic filling of the silos are controlled by individual C&W Model CP-305 baghouses.

Emissions generated from the weigh scale and the loading of mixer trucks are controlled by a Griffin Model D-80 dust collector.
