Dear Mr. Hank Belcher,

This correspondence is a twofold confirmation pursuant to the following:

1) Your letter dated May 15, 2009 (1<sup>st</sup> attached .pdf file) indicating that you have temporarily shutdown the subject item facility (10/31/08) due to a down-turn in the construction industry and your wish to keep your Air General Permit facility registration in an ACTIVE status; and a HOLD on the Visible Emission (VE) Inspections.

With respect to number 1) above, your entitlement for the subject item facility continues to remain ACTIVE. I have entered each ACTIVE Emission Unit as in **Long Term Reserve Shutdown** to put a HOLD on the Visible Emission (VE) Inspections which may come due while the facility is in the shutdown mode. You must notify us when the decision is made to restart operations, in order that we may remove the respective EU's from the Long Term Reserve Shutdown and any HOLD on VE inspections that may have come due. Any annual VE testing, which may have come due during the shutdown period, should be performed upon commencing operation.

2) Your letter dated May 20, 2009 (2<sup>nd</sup> attached .pdf file) requesting an administrative name change to the subject item facility not associated with a change in ownership.

With respect to number 2) above, the administrative name change of the subject item facility is now registered as PREFERRED MATERIALS INC.

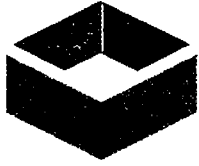
