#### **Facility Fuel & Controls**

This re-registration is for an existing Matthews Cremation Group IE43-PPII human crematory.

The crematory is designed to burn human remains at the average incineration rate of 100 pounds per hour. The incinerator consists of primary and secondary (afterburner) chambers, each fired on natural gas.

Emissions are controlled by the afterburner, which maintains a minimum secondary chamber combustion zone temperature of 1600°F prior to and during combustion of material in the primary chamber. The secondary chamber is designed to ensure one second residence time at a gas temperature of 1800°F, and is equipped with a continuous temperature monitor and recorder.

The unit is equipped with an opacity monitor that controls (e.g. shuts down) the cremation burner if excess emissions are encountered in the stack.
