This application is to change ownership of the facility from Schwab Ready Mix to Preferred Materials, Inc.

The facility consists of an office building, parking area, various aggregate piles and two concrete batch plants with silos to store the materials used in the process of making concrete, a mixer/batcher and truck load out area.

Materials used in the manufacture of concrete will be pneumatically transferred from tanker trucks to storage silos. Emissions from the transfer of materials will be controlled by a central dust collector located at each plant. The emissions from the weigh hopper are controlled by a baghouse.

The following emission points will be in use:

Plant A (Old Plant) 785 bbl Cement Silo 360 bbl Flyash Silo Truck Load out

The above emission points located at Plant A are controlled by a Stephens SLS 6100 Central Dust Collection System.

Weigh Hopper emissions are controlled by a Stephens SV 20.

Plant B (New Plant) 60/40 804 bbl Split Silo Compartment A (60%) Cement Compartment B (40%) Flyash Truck Load out

The above emission points located at Plant B are controlled by a Stephens SLS 6100 Central Dust Collection System

Weigh Hopper emissions are controlled by a Stephens SV 20
