

Plant #2 - Manufactures of concrete precast.

This plant consists of aggregate storage piles, two cement silos ( one gray and one white) with top mounted bag collectors to control particulate emissions, and associated conveyors and mixing equipment.

Plant #3 - Manufactures concrete precast.

This plant consists of aggregate storage piles, four cement silos with top mounted bag collectors to control particulate emissions, and associated conveyors and mixing equipment. This includes the two we are adding to the present Air General Permit Registration.
