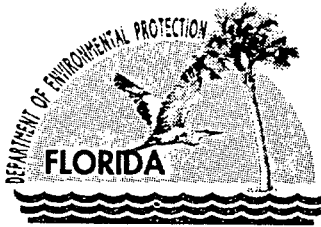

TO: Holder of Title V Air General Permit

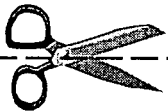

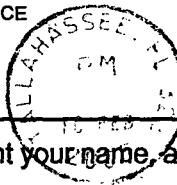
