
This is to acknowledge that your notification of intent to use the authority of Rule 62-210.310 to operate your facility was received on April 14, 2008. We have assigned ARMS No. 0750028-007 to this facility.

As you know, pursuant to Florida Statutes section 403.814, authority to operate under general permits commences thirty days after receipt of the registration form unless you have been notified by this office that your facility has not shown entitlement to operate pursuant to the rule provisions.

For your information, authority to operate pursuant to Rule 62-210.310 expires after 5 years. Therefore, a new registration form must be received no later than 5 years after the date your notice was received as indicated above. If your general permit rule conditions require testing, such testing must be completed within the time frame specified in the rule.



The main roads within the facility are paved to prevent unnecessary emissions from truck traffic. In addition, particulate matter that accumulates on the roads will either be swept or wetted as needed to control fugitive emissions. Material stockpiles will be wetted to control emissions.

Description of Facility

Below, or as an attachment to this form, provide a description of the concrete batching plant operations at the facility in sufficient detail to demonstrate the facility's eligibility for use of this air general permit and to provide a basis for tracking any future equipment or process changes at the facility. This facility has an existing AG permit (0750028) under Trinity Materials L.L.C. Plant #38. This facility was sold to A Materials Group, Inc. (AMGI) on 3/8/08. The purpose of this application is to change the permittee to A Materials Group, Inc. This facility will be denoted as AMGI Plant # 12.

This facility is a ready-mix concrete batch plant. The plant will weigh or meter cement and pozzolans, sand, rock, water and admixtures into mixer trucks. The requested operating schedule is 24 hrs/day, 7 days/week and 52 weeks/year. The typical production rate is approximately 95 cubic yards/hour of wet concrete.

The plant was manufactured by Con-E-Co and has two (2) silos for the storage of cement (112 ton silo) and pozzolans (59 ton silo). Each silo is equipped with Wams Silo Top Dust Collection Baghouses located on the top of each of the silo storage compartments. Emissions during batching are captured by a Con-E-Co vacuum dust collector system. The typical loading rate for the silos will be approximately 25 tons/hr.
