Description of Reasonable Precautions

This facility is provided with an extensive stormwater/wastewater drainage system, which is designed to flush particulate matter from the paved yard and entrance drive. This keeps the paving cleaner, substantially reducing fugitive emissions. Aggregate stockpiles in the yard are kept watered, partly for quality control and partly to reduce potential emissions from these materials. Unused concrete which is brought back to the site is stored in a concrete-walled washout structure, which reduces the area needed to dry the material, while keeping it out of the main traffic pattern, where it would generate additional fugitive emissions.

Description of Facility

Below, or as an attachment to this form, provide a description of the concrete batching plant operations at the facility in sufficient detail to demonstrate the facility's eligibility for use of this air general permit and to provide a basis for tracking any future equipment or process changes at the facility. Ready-Mix Concrete Batching Facility, which utilizes cement, flyash, slag and aggregate materials to produce ready-mix concrete. Dust emissions generated during the filling of the plant's silos or loading of concrete mixer trucks are controlled by cartridge dust collectors. Details of these emissions units (EU's) are as follows:

EU-01 - A tall single-compartment cement/flyash silo (with a baghouse dust collector.)

EU-02 - Two short single-compartment cement/flyash silos (both served by a single baghouse dust collector.)

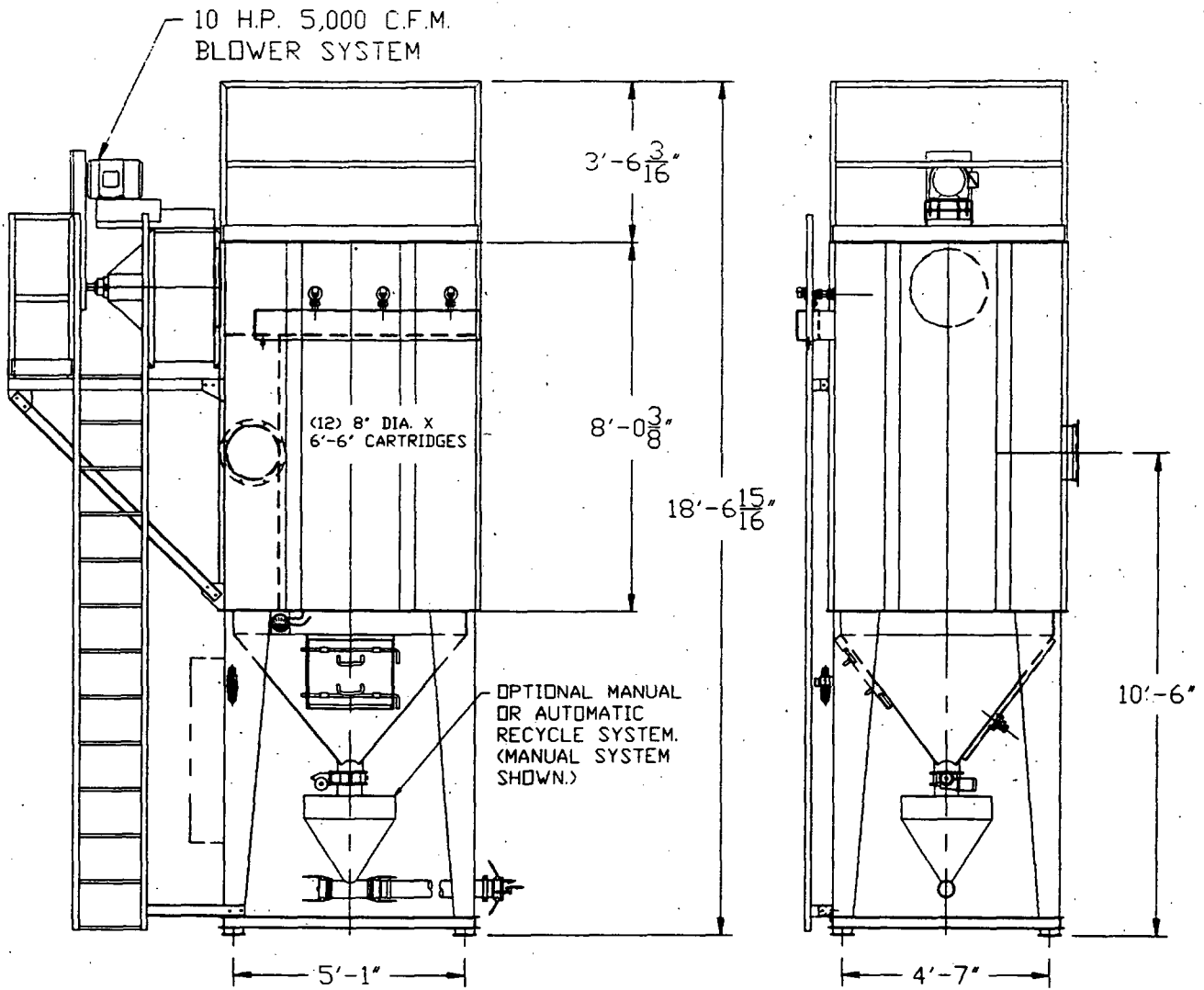
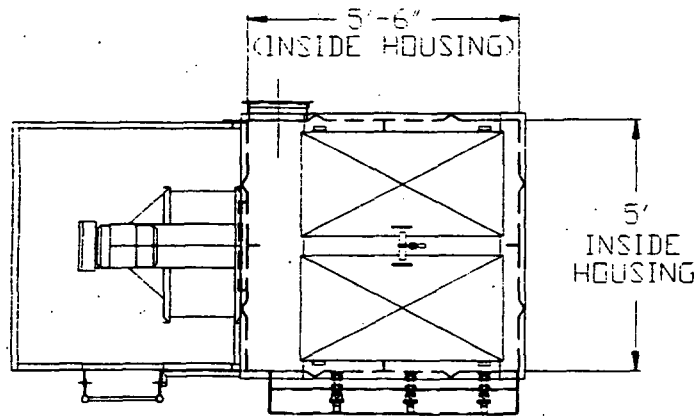
EU-03 - Concrete mixer truck loadout (with a C. & W. Dust Systems Model CP-900-1278 central cartridge dust collector / Proposed.)

Specifically, a C. & W. Dust Systems Model CP-900-1278 cartridge dust collector will be retrofitted to the batch facility's concrete mixer truck loadout. All other existing dust collectors on the batch facility will remain unchanged.

In order to update the general air permit for this location, we have attached an FDEP General Air Registration Form, specifications for the proposed dust collector and check no. 21815097 in the amount of \$100.00. A visible emissions test will be performed on the dust collector within thirty days of its installation.

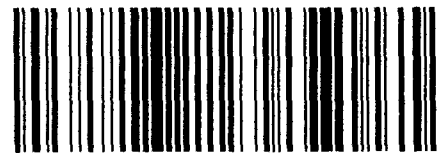
