Pursuant to Florida Statutes section 403.814, the authority to operate under general permits commences (30) thirty days after receipt of the registration form unless you have been notified by this office that your facility has not shown entitlement to operate pursuant to the rule provisions.



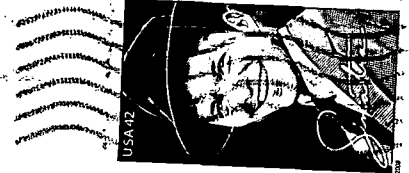
