The Department has received the Title V General Permit Notification Form for the dry cleaning facility that you submitted on February 22, 2007.



### Facility Name and Location

1. **Facility Owner/Company Name** - Enter the name of the corporation, agency, or individual that has ownership or control of the dry cleaning facility for which this notification is submitted.
