The Department has received the Title V General Permit Notification Form for the dry cleaning facility that you submitted on May 27, 2003.





Spoke with Mrs. Chenny Harrilal, wife of president of Ardon's Cleaners, and she stated the dry cleaning machine was new in approximately 1997. The machine has a chiller (refrigerated condenser) and it is built into the dry cleaning machine. Mrs. Harrilal indicated that the transfer washers and dryer listed on the form do not use perchloroethylene. She also stated the natural gas fueled boiler operates at 10 HP.

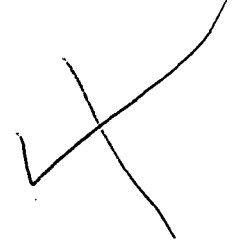



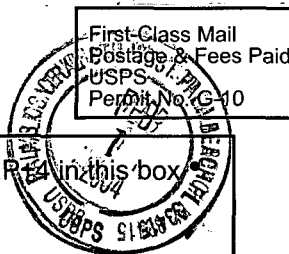
