Mr. Dibble:

Based on a February 23, 2009 inspection at Spartan Cleaners, Inc., dba Spartan Cleaners - #3, located at 3370 Tampa Road, Palm Harbor, FL this facility shutdown for Perchloroethylene dry-to-dry operations. Inspection findings indicate that:

- 1) Perchloroethylene equipment is no longer on the premises.
- 2) The building space previously used by this facility for its operations was leased to another business.
- 3) The facility is requesting the permit be rescinded (copy of letter attached).
- 4) Air Quality intends to deactivate this facility from its tracking files and awaits confirmation from your office that it has been deactivated in the ARMS system.

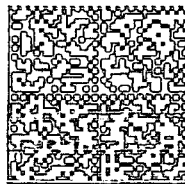
