

Mr. Dickson Dibble,

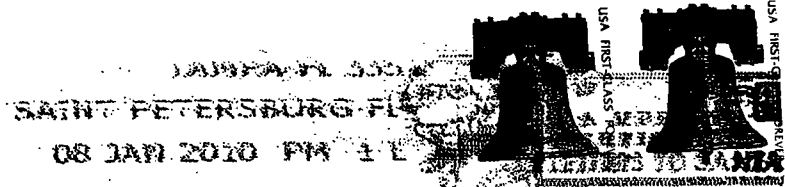
My name is Clark Gamble, president of Clark Gamble Corp DBA Carriage Cleaners. I purchased a 1997 Realstar model T-35 dry cleaning machine on 04/15/2009. The serial number for the Realstar is: 47-A7-131. I replaced a 1989 Miraclean-35, type DCR-G3-0250-TF5-523, The serial number was: 89JT541880. The Realstar became available, and I had a short window of opportunity to purchase it. I had the Realstar installed on 04/15/2009. The Miraclean was drained of all perchlorethylene, which was pumped into drums. The Miraclean was dismantled for parts and hauled away by Gary Nash of Equipment Sales. The Realstar machine was then installed approximately 2 hours later, and was filled with the perchlorethylene that had been removed from the Miraclean. All of the perchlorethylene was recycled, and cooked down in the Realstar. Both of the machines are 35 pound dry-to-dry. My purpose for buying the Realstar was just to upgrade my older machine.
