The Department has received the Title V General Permit Notification Form for the dry cleaning facility that you submitted on September 15, 2006.





Enclosed is a Title V General Permit Notification Renewal for Sacino's Formalwear & Dry Cleaners, 3430 Fairfield Avenue South, St. Petersburg, FL, 33711, which was collected by the inspector on September 11, 2006. The current notification is due to expire on October 6, 2006. The renewal deadline for this general permit was August 7, 2006, and is therefore 35 days past due.

In an effort to prevent the permit from expiring, Air Quality contacted the RO to facilitate the processing of this notification. The facility is in violation of Part II, (2)(a), General Conditions, of the permit that states, no later than 30 days prior to the fifth anniversary of filing of intent to use the general permit, the responsible official shall submit a new notice of intent.

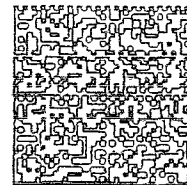
