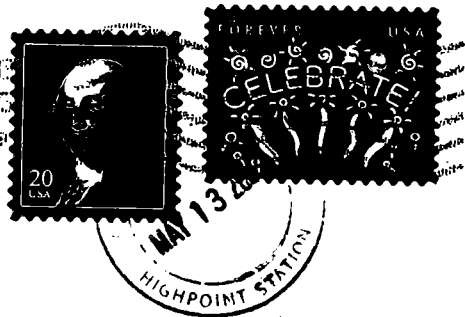
This facility is a u-cart CB3 Concrete batch plant with a 200 barrel cement storage silo that is filled by trucks.
