Currently, one permitted cement silo is in operation and a new one is going to be installed before end of the year. the portland cement is brought to the silo by a tanker truck that offloads into the cement silo by using a sealed pumped system. the City of Lakeland's concrete batch truck then receives cement from the silo that is then taken to the job sites for use. The dust suppression system is monitored and replaced as needed.
