Currently, Star Brite Cleaners is operating as a drop store with a new owner and I would like you to inactivate my permit for this facilities.

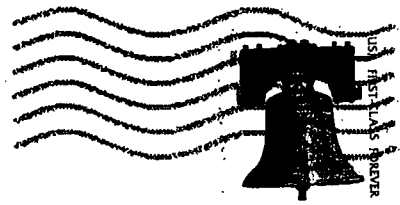
