



This notification is for renewal of 1170373-003-AG.

The facility originally had five (5) raw material storage silos. Those silos are not used at this time, but it is possible they could be used in the future.

The facility currently uses nine (9) raw material storage silos. Each silo has 100-ton storage capacity. Each silo is equipped with a LMC Model 25VSD6 baghouse/dust filter atop the silo. The facility needs flexibility to change which material is stored in any given silo from time to time. However, the current arrangement is as follows:

Silo 1: xo marble

Silo 2: G260 crushed marble

Silo 3: Federal white cement

Silo 4: 20-65 grade quartz sand

Silo 5: 40-140 grade quartz sand

Silo 6: 20-65 grade quartz sand

Silo 7: 8-30 grade quartz sand

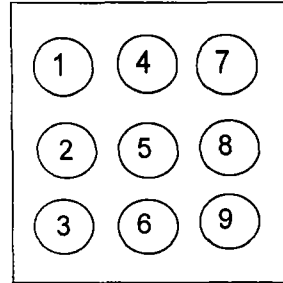
Silo 8: 8-30 grade quartz sand

Silo 9: 8-30 grade quartz sand

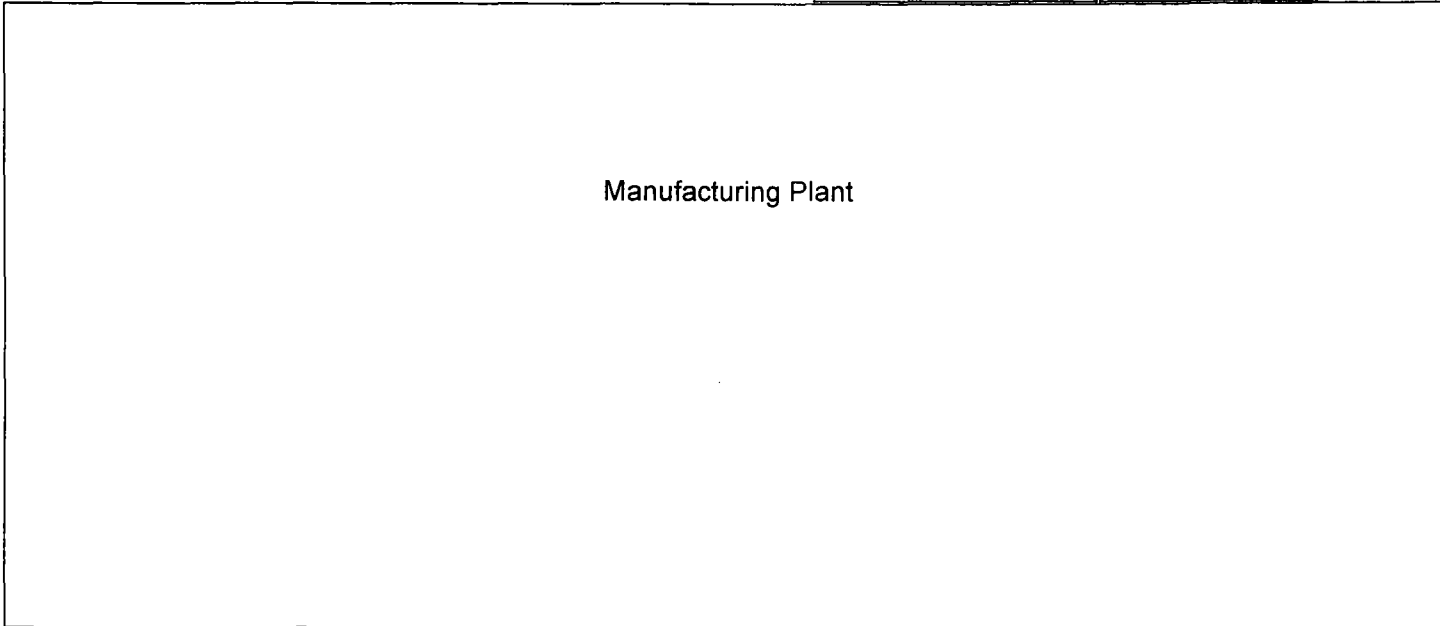
In addition, the process area has three (3) 100-cu.ft. mixers, one (1) 75-cu.ft. mixer, and four (4) baggers. A MicroPul 100 HP Pulse Jet Collector dust collection system controls dust from the mixers and baggers.
