I inspected the outside of the facility at that time. It appeared to be in long term shutdown. I wasn't able to inspect the interior though because the facility was locked and no one was on site. The business adjacent to the animal crematory indicated that it was no longer in business. I subsequently contacted the owner of Tri-county Animal Crematory, a Mr. Kyle McDonald, and he stated that he sold the unit

and was no longer in business. I informed him that he needed to notify the Department of this and gave him our nwdair email address so that he can write an email surrendering his permit. I called him a few more times to remind him to send the email. Once he finally sent it, I did not attempt to contact him further.
