Description of Facility

This facility has a RAP crusher for crushing recycled asphalt cement. It was previously permitted under an air operating permit which included an asphalt batch plant. The batch plant was sold and SCI is surrendering the operating permit and applying for an air general permit for the RAP crusher.

The RAP crusher is a Lippman Model #4248 LP and is powered by electric. There is also an electric screening plant associated with the crusher and it is a Trio APS Model #4034, the serial number is unknown for these due to the age of the equipment.

There are some other changes included in this application for this facility so we would like to include all of the equipment under the current facility ID number of 7775249. This permit currently has two primary crushers and the following equipment changes are going to take place:

The engine for the Universal crusher Model 4555, is going to be replaced with a CAT C18 Tier 3 engine, serial number 554X121 (previously CAT Model 3408)

There are two identical portable crushers that were previously permitted and located at another mine that are going to be used at this facility and relocated as needed. Both of them are Metso diesel engine crushers. The first one is Model #LT1213, serial number 72111 and the second is Model #LT1213, serial number 72769.

Below is an updated summary list of the equiptment at this facility (1 RAP Crusher, Screening Plant & 3 limerock crushers):

Recycle Plant: Lippman 4248 LP

Screening Plant: Trio APS 4034

Limerock Crushers: Universal Model 4555 (CAT engine) Metso Model LT 1213 Metso Model LT 1213

Finally, the Cedar Rapids crusher that was permitted under 7775249 has been removed and will not be back so it is no longer included in this permit.


