Thank you for the updated signature page.

- 1) Yes, I do need a good site name other than the S/N of the unit. Just send me an e-mail to that effect and I will attach as an addendum to the registration form.
- 2) FYI Relocatable units, unlike stationary units are assigned a 777XXXX number. That 777 number identifies the unit as relocatable and that number goes wherever the unit goes in the State of Florida and is specific to the equipment being entitled. That number does not a entitle a particular site or a piece of property where the equipment is being utilized. When a relocatable unit is sold or transferred out of the country the status of the 777XXXX is changed to INACTIVE. If that equipment should ever come back the facility status will be changed back to ACTIVE. The bottom line is that when Earth Tech Enterprises sold that piece of equipment (BLPEGSON, TRAKPACTOR 428, 300 T/hr) they have a responsibility to notify us and request INACTIVATION.
- 3) This new unit (BL PEGSON, TRAKPACTOR 1412, S/N 140132CG, 500 T/hr) will be entitled under a new 777XXXX number as long as it has not been entitled prior to this. If it has been permitted prior to this, with another company, then we need to find out the previous ARMS ID #, so it can be reregistered as a change of ownership.

Please let me know as soon as possible if the new unit has ever been entitled in the State of Florida.
