This is an application to operate a relocatable non metallic mineral crusher manufactured by *TEREX* on *JAN. 2011*. It is a Model *XA 400S*, SN*XA40S10MB32407*. The crusher is powered by a *CAT C9 TIER 3/230 HP* engine at *1600 RPM*. The belt is *30'* long *3'13"* wide with a discharge height of *12'10"*. The design capacity is 200 TPH. There are three spray bars on the crusher, one is located at the in-feed to the crusher, the second bar is located at the out-put and the third bar is located at the end of the product discharge conveyor. Each bar is 48" long.

This unit is owned by Powerscreen of Florida, Inc. and is intended to be used as lease/rental equipment. Powerscreen of Florida, Inc. will not be operating or overseeing the operation of this machine.

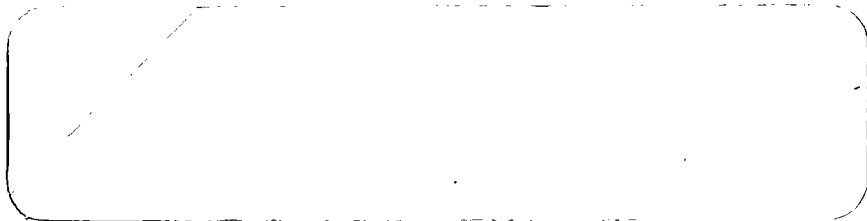
