Dear Mr. Cleveland:

This is to acknowledge that your notification of intent to use the authority of Rule 62-210.310 to operate your facility was received on February 13, 2008. We have assigned ARMS No. 7775042-005 to this facility.

As you know, pursuant to Florida Statutes section 403.814, authority to operate under general permits commences thirty days after receipt of the registration form unless you have been notified by this office that your facility has not shown entitlement to operate pursuant to the rule provisions.

For your information, authority to operate pursuant to Rule 62-210.310 expires after 5 years. Therefore, a new registration form must be received no later than 5 years after the date your notice was received as indicated above. If your general permit rule conditions require testing, such testing must be completed within the time frame specified in the rule.

This portable crushing plant consists of a Astech Primary Crusher, a Deister Screen Deck and a Radial Stacker. The unit is powered by a Caterpillar Diesel Engine. This unit is primarly used to crusher broken concrete and recycled asphalt products (RAP) that are generated from the road construction business. This material is usually hauled to a storage yard or back to one of our asphalt plants. When enough material has been stocked piled, the crusher is relocated to the facility to process the material. Once finished, the crusher is moved to another site.

When required, ACCI will modify the permits (i.e. AO permits) of those facilities that will use a portable crusher.

Emissions are usually generated at the primary crusher, however stockpiles, interior roads and material handling processes can generate some air emissions. ACCI controls these emissions by apply a water mist at these points. Fugitive emissions from truck traffic can be eliminated by the use of a water truck and by controlling any unnecessary truck traffic through the area.


