This is an application to operate a relocatable non metallic mineral crusher manufactured by Powerscreen on Nov. 2012. It is a Model KH320, SNKH320KOMC95765. The crusher is powered by at Scania 069325HP engine at 2000 RPM. The belt is 35' long, 39" wide with a discharge height of 11'4". The design capacity is 200 TPH. There are three spray bars on the crusher, one is located at the in-feed to the crusher, the second bar is located at the out-put and the third bar is located at the end of the product discharge conveyor. Each bar is 48" long.

This unit is owned by Powerscreen of Florida, Inc. and is intended to be used as lease/rental equipment. Powerscreen of Florida, Inc. will not be operating or overseeing the operation of this machine.
