

Enclosed is operation permit Number 0112598-008-AF to operate an air pollution source issued pursuant to Section 403.087 of the Florida Statutes, Broward County’s Specific Operating Agreement with the Florida Department of Environmental Protection, and Broward County Code Chapter 27 Article IV which adopts Florida Administrative Code (FAC) 62-4, 62-204, 62-210, 62-296 and 62-297.

Persons whose substantial interests are affected by this permit have a right, pursuant to Section 120.57, Florida Statutes, to petition for an administrative determination (hearing) on it. The petition must conform to the requirements of Chapters 62-103 and 28-5.201, FAC, and must be filed (received) in the Pollution Prevention, Remediation and Air Quality Division (PPRAQ), 115 South Andrews Avenue, Room A-240, Fort Lauderdale, Florida 33301 within fourteen (14) days of receipt of this notice. Failure to file a petition within the fourteen (14) days constitutes a waiver of any right such person has to an administrative determination (hearing) pursuant to Section 120.57, Florida Statutes and Chapter 27.

This permit is final and effective on the date filed with the Clerk of the PPRAQ unless a petition is filed in accordance with this paragraph or unless a request for extension of time in which to file a petition is filed within the time specified for filing a petition and conforms to Rule 62-103.070, FAC. Upon timely filing of a petition or a request for an extension of time, this permit will not be effective until further Order of the PPRAQ. When the Order (Permit) is final, any party to the Order has the right to seek judicial review of the Order pursuant to Section 120.68, Florida Statutes, by the filing of a Notice of Appeal pursuant to Rule 9.110, Florida Rules of Appellate Procedure, with the Clerk of the Pollution Prevention, Remediation and Air Quality Division, 115 South Andrews Avenue, Room: A-240, Fort Lauderdale, FL 33301; and by filing a copy of the Notice of Appeal accompanied by the applicable filing fees with the appropriate District Court of Appeal. The Notice of Appeal must be filed within 30 days from the date the Final Order is filed with the Clerk of the PPRAQ.

This permit is issued under the provisions of Chapter 403, Florida Statutes (F.S.) Florida Administrative Code (F.A.C.) Rules 62-4 and 62-204 through 62-297 (permitting requirements) and Broward County Code, Chapter 27 (emission limitations) and in conformance with all existing regulations of the Florida Department of Environmental Protection (DEP). The above named Permittee is hereby authorized to perform the work or operate the facility shown on the application and approved drawing(s), plans, and other documents attached hereto or on file with the Broward County Pollution Prevention, Remediation and Air Quality Division (PPRAQ) and made a part hereof and specifically described as follows:

**Operate:** An air pollution source consisting of a custom wood cabinetry and millwork manufacturing facility. This facility is located in one contiguous area comprising 1505 - 1551 South 30<sup>th</sup> Avenue in Hollywood. The following are the regulated emission units:

**EU#001:** One Mica spray booth located at 1525 South 30<sup>th</sup> Avenue, Hollywood.

**EU#002:** One Makor spray machine, one 25,000 scfm DISA Model 5HL polyester filter bank dust collector with 26.6" diameter exhaust stack at 30 feet in height and one Torit dust collector. The dust collectors are located outside of the main building. This emissions unit is located at 1551 South 30<sup>th</sup> Avenue, Hollywood.

**EU#003:** Two spray booths, one automatic spray machine and one mixing room. This emissions unit has three emissions points which are a Cefla reciprocating spray machine, Keen Spray 12, floor type open face spray booth and the mixing room. This emissions unit is located at 1505 South 30<sup>th</sup> Avenue, Hollywood.

Also, there is a Torit Down flow dust collector inside the building, which does not exhaust to the outside, located at 1525 S. 30<sup>th</sup> Avenue, Hollywood and it is considered an exempt and unregulated air pollution control equipment at the location.

**In accordance with:** Broward County "License to Construct an Air Pollution Source" issued December 31, 1998, state general permit issued January 4, 1999, application to obtain federally enforceable state operation permit (FESOP) received August 15, 2003, additional information received September 19 and December 18, 2003, Public Notice of Intent to Issue Permit issued March 12, 2004 and published March 28, 2004 in the Sun-Sentinel newspaper, proof of publication received April 1, 2004, application for permit to construct received December 18, 2003, Public Notice of Intent to Issue Permit issued January 14, 2004 and published on January 28, 2004 in the Sun-Sentinel newspaper, application to obtain operation permit received December 6, 2004, additional information received January 5, 2005, application for permit to construct received July 17, 2007, additional information received August 28, 2007, Public Notice of Intent to Issue Permit issued September 14, 2007 and published on October 6, 2007 in the Sun-Sentinel newspaper, application to obtain operation permit received January 9, 2008; and application to renew operation permit received January 21, 2009, additional information received March 30, 2009 (none are attached).

**Location:** 1505 South 30<sup>th</sup> Avenue and 1551 South 30<sup>th</sup> Avenue, Hollywood, Broward County, Florida.

**To serve:** A Wood Cabinetry and Millwork (SIC #: 2599)

**Subject to:** General Conditions 1-16, Facility-Wide Conditions 17-24 and Specific Conditions 25-31.

### General Conditions

1. Terms of Permit. The terms, conditions, requirements, limitations and restrictions set forth in this permit, are “permit conditions” and are binding and enforceable pursuant to Sections 403.141, 403.727, or 403.859 through 403.861, F.S. The Permittee is placed on notice that the PPRAQ will review this permit periodically and may initiate enforcement action for any violation of these conditions.

2. Permit Validity. This permit is valid only for the specific processes and operations applied for and indicated in the approved drawings or exhibits. Any unauthorized deviation from the approved drawings, exhibits, specifications, or conditions of this permit may constitute grounds for revocation and enforcement action by the PPRAQ.

3. Disclaimer. As provided in subsections 403.087(6) and 403.722(5), F.S., the issuance of this permit does not convey any vested rights or exclusive privileges. Neither does it authorize any injury to public or private property or any invasion of personal rights, or any violations of federal, state or local laws or regulations. This permit is not a waiver of or approval of any other permit that may be required for other aspects of the total project which are not addressed in this permit.

4. Disclaimer. This permit conveys no title to land or water, does not constitute State recognition or acknowledgment of title, and does not constitute authority for the use of submerged lands unless herein provided and the necessary title or leasehold interest have been obtained from the State. Only the Trustees of the Internal Improvement Trust Fund may express State opinion as to title.

5. Liability. This permit does not relieve the Permittee from liability for harm or injury to human health or welfare, animal, or plant life, or property caused by the construction or operation of this permitted source, or from penalties therefore; nor does it allow the Permittee to cause pollution in contravention of Florida Statutes and DEP rule, unless specifically authorized by an order from the PPRAQ.

6. Operation and Maintenance. The Permittee shall properly operate and maintain the facility and systems of treatment and control (and related appurtenances) that are installed and used by the Permittee to achieve compliance with the conditions of this permit, as required by county and state rules. This provision included the operation of backup or auxiliary facilities or similar systems when necessary to achieve compliance with the conditions of the permit and when required by PPRAQ and DEP rules.

7. Onsite Inspection Activities. The Permittee, by accepting this permit, specifically agrees to allow authorized PPRAQ personnel, upon presentation of credentials or other documents as may be required by law and at reasonable times (depending on the nature of the concern being investigated), access to the premises where the permitted activity is located or conducted to:
  - (a) Have access to and copy any records that must be kept under conditions of the permit;
  - (b) Inspect the facility, equipment, practices, or operations regulated or required under this permit; and

- (c) Sample or monitor any substances or parameters at any location reasonably necessary to assure compliance with this permit or PPRAQ and DEP rules.

8. **Notice of Noncompliance.** If, for any reason, the Permittee does not comply with or will be unable to comply with any condition or limitation specified in this permit, the Permittee shall immediately provide PPRAQ with the following information:  
(a) A description of and cause of noncompliance; and  
(b) The period of noncompliance, including dates and times, or, if not corrected, the anticipated time the noncompliance is expected to continue, and steps being taken to educe, eliminate, and prevent recurrence of the noncompliance. The Permittee shall be responsible for any enforcement action by PPRAQ for penalties or for revocation of this permit.

9. **Reporting Noncompliance.** The Permittee shall report any periods of noncompliance to the PPRAQ immediately by phone at 954-519-1499 or by Email at [EPDHOTLINE@broward.org](mailto:EPDHOTLINE@broward.org). This also applies when the period of noncompliance is first determined after normal business hours or on weekends and holidays.

10. **Evidence Materials.** By accepting this permit, the Permittee understands and agrees that all records, notes, monitoring data and other information relating to the construction or operation of this permitted facility or activity, that are submitted to the PPRAQ as evidence in any enforcement proceeding arising under the Florida Statutes or F.A.C. rules, except where such use is prohibited by Section 403.111 and 403.73, Florida Statutes. Such evidence shall only be used to the extent it is consistent with the Florida Rules of Civil Procedure and appropriate evidentiary rules.

11. **Rule Changes.** The Permittee agrees to comply with changes in Florida Department of Environmental Protection rules and Florida Statutes after a reasonable time for compliance; provided, however, the Permittee does not waive any other rights granted by Florida Statutes or DEP rules.

12. **Permit Transfer.** This permit is transferable only upon PPRAQ approval in accordance with Rule 62-4.120 and 62-730.300 F.A.C., as applicable. The Permittee shall be liable for any non-compliance of the permitted activity until the transfer approved by the PPRAQ.

13. **Work Site Copy.** This permit or a copy thereof shall be kept at the work site of the permitted activity.  
[Rules 62-4.160 (12), F.A.C.]
14. **Miscellaneous Compliance Requirements.** The Permittee shall comply with the following:  
(a) Upon request, the Permittee shall furnish all records and plans required under DEP rules. During enforcement actions, the retention period for all records will be extended automatically unless otherwise stipulated by the PPRAQ.

(b) The Permittee shall hold at the facility or other location designated by this permit records of all monitoring information (including all calibration and maintenance records and all original strip chart recording for continuous monitoring instrumentation) required by the permit, copies of all reports required by this permit, and records of all data used to complete the application for this permit. These materials shall be retained at least three years from the date of the sample, measurement, report, or application unless otherwise specified by PPRAQ rule.

(c) Records of monitoring information shall include:

1. The date, exact place, and time of sampling or measurements;
2. The person responsible for performing the sampling or measurements;
3. The dates on which analyses were performed.
4. The person responsible for performing the analyses;
5. The analytical techniques or methods used;
6. The results of such analyses.

15. Information Submittal. When requested by the PPRAQ, the Permittee shall within a reasonable time furnish any information required by law which is needed to determine compliance with the permit. If the Permittee becomes aware the relevant facts were not submitted or were incorrect in the permit application or in any report to the PPRAQ, such facts or information shall be corrected promptly.

16. Rules Adoption. Chapters 62-4, 62-204, 62-210, 62-212, 62-213, 62-296 and 62-297, as amended, are adopted by Broward County Code, Sec. 27-173.

#### **Facility-wide Conditions**

17. Objectionable Odor. No person shall cause, suffer, allow or permit the discharge of air pollutants which cause or contribute to an objectionable odor.

[Rule 62-296.320(2), F.A.C.]

18. VOC or Organic Solvents Emissions. The owner or operator shall allow no person to store, pump, handle, process, load, unload or use in any process or installation, volatile organic compounds or organic solvents without applying known and existing vapor emission control devices or systems deemed necessary and ordered by the PPRAQ. The following requirements are deemed necessary by PPRAQ:

- (a) Tightly covering or closing all VOC containers when they are not in use.
- (b) Tightly covering, where possible, all open troughs, basins, baths, tanks, etc. when they are not in use.
- (c) Immediately confining and cleaning up VOC spills and ensuring that discarded hazardous materials are placed in closed containers for reuse, recycling or proper disposal.

19. Concealment. No person shall build, erect, install, or use any article, machine, equipment or other contrivance, the use of which will conceal any emission which would otherwise constitute a violation of any provisions of Broward County Code.

20. Circumvention. No person shall circumvent any air pollution device, or allow the emission of air pollutants without the applicable air pollution control device operating properly.  
[Broward County Code, Sec. 27-175(c)]
21. Maintenance. No person shall operate any air pollution control equipment or systems without proper and sufficient maintenance to assure compliance with Broward County Code.  
[Broward County Code, Sec. 27-175(d)]
22. General Visible Emissions Standard. Unless otherwise specified by permit or rule, no person shall cause, let, permit, suffer or allow to be discharged into the atmosphere the emissions of air pollutants from any activity, the density of which is equal to or greater than 20 percent opacity.

23. Excess emissions resulting from start up, shutdown or malfunction of any emissions unit shall be permitted providing best operational practices to minimize emissions are adhered to, and the duration of excess emissions shall be minimized but in no case exceed two hours in any 24 hour period unless specifically authorized by PPRAQ for longer duration. Excess emissions which are caused entirely or in part by poor maintenance, poor operation, or any other equipment or process failure which may reasonably be prevented during start up, shutdown, or malfunction shall be prohibited. The excess emissions at this facility are quantified and verified through records maintained of particulate matter emissions calculations as outlined in Specific Condition #26 of this permit.

24. Unconfined Emissions of Particulate Matter. The permittee shall take reasonable precautions to control emissions of fugitive particulate matter. Reasonable precautions may include but shall not be limited to the following:
  - a. Paving and maintenance of roads, parking areas and yards;
  - b. Application of water to control emissions from such activities as demolition of buildings, grading roads, construction, and land clearing;
  - c. Removal of particulate matter from roads and other paved areas under the control of the owner or operator of the source to prevent reentrainment, and from buildings or work areas to prevent particulate matter from becoming airborne;
  - d. Landscaping or planting of vegetation
  - e. Use of hoods, fans, filters and similar equipment to contain, capture and/or vent particulate matter;
  - f. Enclosure or covering of conveyor systems[Rule 62-296.320(4) (c) F.A.C.; Broward County Code, Sec. 27-177(b)]

## Specific Conditions

### Emission Limiting Standards

25. In order to avoid major source (Title V) applicable standards, volatile organic compounds (VOC) shall not exceed 99 tons in any consecutive twelve-month period, individual hazardous air pollutants (HAP) shall not exceed 9.9 tons in any consecutive twelve-month period and total hazardous air pollutants (HAPs) shall not exceed 24 tons in any consecutive twelve-month period.  
[Requested by the applicant in the construction permit application received July 17, 2007 and already incorporated in the permit 0112598-003-AF, Rule 62-4.070(3), F.A.C.]

### Recordkeeping and Reporting Requirements

26. The owner or operator shall keep-up-to date, readily accessible records for the life of the control equipment to include wood dust disposal records to document wood processed through the dust collection system. This facility opts to keep records of the particulate matter emissions calculations on a twelve-month rolling basis.

27. VOC Content: The owner or operator shall determine the VOC content of all solvent based materials, coatings and solvents used, and shall monitor the usage of such materials at the referenced emission unit by recording and maintaining the following information:
- The VOC content for each material containing or emitting VOC.
  - The material utilization rate on a monthly basis, for all materials containing or emitting VOC used at the referenced emission unit(s).
  - The total monthly VOC emission rates for each material, calculated from the monthly material utilization rates and the VOC content, calculated for the preceding month no later than 20 days after the end of that month.
  - A rolling consecutive 12-month total emission rate for VOC, calculated from the monthly totals for the previous twelve calendar months.
  - Maintain Material Safety Data Sheets (MSDS) for all volatile materials utilized.  
[Rule 62-4.070(3), F.A.C.]
28. Total and Individual HAP Content: The owner or operator shall determine the total and individual HAP contents of all solvent based materials, coatings, and solvents used, and shall monitor the usage of such materials at the referenced emission unit by recording and maintaining the following information:
- The individual and total HAP contents for each material containing or emitting HAPs.
  - The material utilization rate on a monthly basis, for all materials containing or emitting HAPs used at the referenced emission unit(s).
  - The individual and total monthly HAP emission rates for each material, calculated from the monthly material utilization rates and the individual and total HAP content, calculated for the preceding month no later than 10 days after the end of that month.
  - A rolling consecutive 12-month total emission rate for individual and total HAPs, calculated from the monthly totals for the previous twelve calendar months.

e. Maintain Material Safety Data Sheets (MSDS) for all volatile materials utilized.  
[Rule 62-4.070(3), F.A.C.]

29. Annual Operating Report (AOR). The AOR shall be submitted to the PPRAQ by April 1 of the following year, except that the annual operating report for the year 2008 shall be submitted by May 1, 2009. If the report is submitted using FDEP's electronic annual operating report software (EAOR), there is no requirement to submit a copy to PPRAQ.

#### Other Requirements

30. When the PPRAQ, after investigation, has good reason to believe (such as complaints, increased visible emissions or questionable maintenance of control equipment) that any applicable emission standard in F.A.C. Rules 62-204 through 62-297 or in a permit issued pursuant to those rules is being violated, it shall require the owner or operator of the emissions unit to conduct compliance tests which identify the nature and quantity of pollutant emissions from the emissions unit to provide a report on the results of said tests to PPRAQ.

#### Renewal Requirements

21. Operating Permit Renewal. Sixty days before the expiration date of this operation permit, the Permittee shall apply for a renewal of permit using the forms incorporated by reference in the specific rule chapter for this type of permit.
