Enclosed is Final Permit Number 0310316-004-AF to operate the subject air pollution source, issued pursuant to Section 403.087, Florida Statutes (FS). The purpose of this FESOP is to establish federally enforceable limitations on the facility and affected emission units that will effectively change the status of the facility to Non-Title V. Also, there is a requirement that the Responsible Official submit a Statement of Compliance within 60 days of the issuance date of the FESOP in accordance with Rule 62-213.440(3)(a)2.b., Florida Administrative Code (FAC).

Any party to this Order (permit) has the right to seek judicial review of the permit pursuant to Section 120.68, FS, by the filing of a Notice of Appeal pursuant to Rule 9.110, Florida Rules of Appellate Procedure, with the Clerk of the Department in the Office of General Counsel, City of Jacksonville, 117 West Duval Street, Suite 480, Jacksonville, FL 32202, and with the Clerk of the Department of Environmental Protection in the Office of General Counsel, Mail Station 35, 3900 Commonwealth Boulevard, Tallahassee, FL, 32399-3000, and by filing a copy of the Notice of Appeal accompanied by the applicable filing fees with the appropriate District Court of Appeal. The Notice of Appeal must be filed within 30 days from the date this Notice is filed with the Clerk of the Department.
