Enclosed is the final air construction permit, which authorizes revisions to the air construction permit for the sludge dryer at the Southeast Water Reclamation Facility, which is co-located in with the Manatee County Lena Road Landfill at 3331 Lena Road in Bradenton, Florida. As noted in the attached Final Determination, only minor changes and clarifications were made to the draft permit. This final permit is issued pursuant to Chapter 403, Florida Statutes.

Any party to this order has the right to seek judicial review of it under Section 120.68 of the Florida Statutes by filing a notice of appeal under Rule 9.110 of the Florida Rules of Appellate Procedure with the clerk of the Department of Environmental Protection in the Office of General Counsel (Mail Station #35, 3900 Commonwealth Boulevard, Tallahassee, Florida, 32399-3000) and by filing a copy of the notice of appeal accompanied by the applicable filing fees with the appropriate District Court of Appeal. The notice must be filed within 30 days after this order is filed with the clerk of the Department.
