We have reviewed your permit and noted that an annual operating permit is not required pursuant to Rule 62-210.370(3), F.A.C. Pursuant to this review, the specific condition 5.1 in both permits is deleted.

**Annual Operations Report:** Before March 1st of each year, the owner or operator shall submit an Annual Operations Report [DEP Form No. 62-210.900(5)] to the Health Department which summarizes operations for the previous calendar year. [Rule 62-210.370(3), F.A.C.]

A person whose substantial interests are affected by the Department's proposed permitting decision may petition for an administrative hearing in accordance with sections 120.569 and 120.57, F.S. The petition must contain the information set forth below and must be filed (received) in the Palm Beach County Health Department Legal Office, located at 826 Evernia Street in West Palm Beach, Florida, 33401 (Telephone: (561) 355-3007, Fax (561) 804-9405). Petitions filed by the permit applicant or any of the parties listed below must be filed within fourteen days of receipt of this modification. A petitioner must mail a copy of the petition to the applicant at the address indicated above, at the time of filing. The failure of any person to file a petition within the appropriate time period shall constitute a waiver of that person's right to request an administrative determination (hearing) under sections 120.569 and 120.57, F.S., or to intervene in this proceeding and participate as a party to it. Any subsequent intervention will be only at the approval of the presiding officer upon the filing of a motion in compliance with Rule 28-106.205, F.A.C.

A petition that disputes the material facts on which the permitting authority's action is based must contain the following information:

- (a) The name and address of each agency affected and each agency's file or identification number, if known;
