The withdrawal is conditioned upon changes agreed to between the Department of Environmental Protection (DEP) and GRU, which are reflected in the document attached as Exhibit A.



Bruce,

I understand Monday is your "drop-dead" date for the proposed permit. Rob is out-of-town today and I have been able to do only a very quick cursory review but have a few comments as indicated below. I have asked Rob to contact you early Monday AM to resolve any remaining issues.

Comments:

In Condition C.6, we request that footnote (a) be changed to "4-hour rolling average".

In Condition C. 13.a., line 8 we request that the word "average" between "hour" and "NOx concentration" be deleted. The existing wording suggests that we first calculate a three-hour block average and then average it with the hourly NOx value for hour for which we are calculating a 4-hour rolling average. Also, the word "hour" should be changed to "hourly".

In Condition C.13.a, in the last sentence wording should be added such that the sentence reads: "Periods of startup, shutdown, ... shall be monitored and recorded but shall be excluded from the calculation of a 4-hour rolling average."

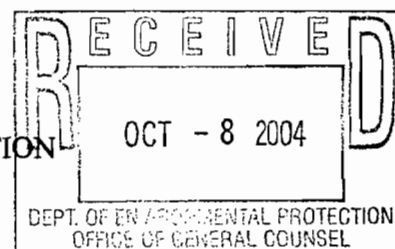





I think I misspoke-

As long as they have published their notice in the newspaper, third party timeframes to challenge the permit have started. These 3<sup>rd</sup> parties will have 14 days from date of publication to challenge the permit. To preserve their rights to be a "party" should any 3<sup>rd</sup> party file a challenge, the company would also need to challenge their own permit. So, I'd say it makes sense to allow them just enough time to see if a third party has, indeed, challenged the permit. We need them to withdraw their extensions by NO later than November 15 [and preferably earlier so we can get proposed to EPA]. Maybe extend until November 1?
